- The Rashan portal can also be directly accessed through Rass.pass.gov.pk
- Branding for the Rashan program, similar to the Cash Program will be added after PM's approval

Beneficiaries will express need for Roshan through the beneficiary registration page

- An “About Roshan” section will provide details of the Roshan program model

- Beneficiary submits address details for delivery of Roshan

- Beneficiary submits through request through the “Submit” button

- Beneficiary gives consent for information sharing with 3rd parties for delivery of Roshan

- Beneficiary enters name, CNIC, CNIC Issue date, marital Status, and mobile number

- Donor organizations will be contacted to submit relevant documents to ensure they meet the eligibility criteria
- Eligible organizations will be mandated to sign relevant data sharing agreements to formalize the partnership
- Formally partnered organizations will be sent data of registered beneficiaries so they can disburse Rashan

Criteria for corporate/private organisations

Documents which will be requested from Organization

- Copy of **SECP registration** certificate
- Copy of **tax registration certificate** from FBR with NTN
- **Copy of certificate from company's financial auditor** stating satisfactory completion of audits
- Proof of **annual revenue of at least PKR 2 bn** (e.g. through declaration on company letter head)

Additional conditions

- Organization is willing to **donate at least PKR 10 Million** in ration packs or cash equivalent
- Organization **agrees to conditions laid out by GoP in the MOU and NDA**, and any data privacy conditions
- Organization has **no known history of engaging in unlawful/unethical practices**
- Organization does not do business in **harmful products** like tobacco, alcohol, drugs etc.

Criteria for not-for-profit organisations

Documents which will be requested from Organization

- Copy of **SECP registration** certificate
- Copy of **certification from Pakistan Center of Philanthropy**
- Copy of **MoU with EAD** (if organization is a local NGO receiving international funding)
- Copy of **registration certificate with Ministry of Interior** (if organization is an international NGO)
- Copy of **tax registration certificate** from FBR with NTN
- Copy of **annual report of activities** (any reports highlighting the organization's activities over the previous year)

Additional Conditions

- Organization is willing to **donate at least PKR 10 Million** in ration packs or cash equivalent
- Organization **agrees to conditions laid out by GoP in the MOU and NDA**, and any data privacy conditions
- NGO has **no known history of engaging in unlawful/unethical practices**
